General Information

AGRO-PHITE MZ is a concentrated, soil-applied nutrient solution containing certain elements beneficial to plant growth and development. **AGRO-PHITE MZ** is for use as a supplemental treatment to a regular fertility program and will not supply the total nutrients required by a crop. Upon foliar application, the phosphite ions are taken up directly by the plant foliage and may undergo a degree of conversion to phosphate ions, or will be used directly by plants as phosphite ions. As a soil application to annual crops, a lesser response from initial crop, with a corresponding superior response from subsequent crops, may be observed. In addition, placement close to seeds or root zones may be injurious to crops. The effect may be aggravated by a soil pH below 6.5.

FOLIAR-APPLIED: **AGRO-PHITE MZ** for foliar applications, whether by aerial or ground application, should be applied with enough water to thoroughly cover all foliage. Early morning or late evening applications generally give the best results. Do not exceed a product concentration of 2% V/V maximum.

SOIL-APPLIED: the best application practice for **AGRO-PHITE MZ** is to water the crop with any available means, by drip irrigation or side dressing. Add the product toward the end to allow it to penetrate the soil and to remain in the root zone.

MIXING INSTRUCTIONS: **AGRO-PHITE MZ** is compatible with most liquid fertilizers and chemicals. Always perform a jar test for compatibility prior to mixing. Follow all directions and precautions on pesticide labels prior to mixing. Use only according to the label instructions.
