Multiple foliar applications at low rates during the growing season may be the most effective because Boron does not easily translocate within the plant. Use a minimum of 50 gallons of water per acre.</p> <p>SOIL-APPLIED: BORON-10 Apply in liquid fertilizer or in water sufficient to give complete coverage. Soil-applied Boron must be moved to the root zone in order to gain absorption into the plant. This may be facilitated by irrigation, rainfall or tillage.</p> <p>MIXING INSTRUCTIONS: BORON-10 is compatible with most liquid fertilizers and chemicals. Always perform a jar test for compatibility prior to mixing. Avoid sulfates and acid blends.
