## **General Information**

**Citrus&CROPS-H** is a source of EDDHA-chelated Cobalt, Copper, Iron, Manganese and Zinc readily available to the plant in Alkaline, Acidic and Calcareous soils. The most effective application time for **Citrus&CROPS-H** is during vegetative plant growth.

SOIL-APPLIED: Citrus&CROPS-H can be applied to the root zone through drip irrigation, micro-sprinkler or side-dressing, and can easily be mixed with other chemicals or fertilizers without reacting with other materials. If using Citrus&CROPS-H with liquid fertilizers, use the recommended rate (see right) of Citrus&CROPS-H and add to the liquid fertilizer solution. When used with dry fertilizers, spray 2 to 10 qt / acre of Citrus&CROPS-H to assure reaching root depth. Side Dress: Use 2 to 10 qt / acre.

**FOLIAR-APPLIED:** Apply **1 to 6 pt / acre** for all crops. When **Citrus&CROPS-H** is used for foliar applications, whether by aerial or ground application, apply with enough water to thoroughly cover all foliage. Early morning or late evening applications generally give the best results. The use of surfactants / adjuvants is not recommended when using the highest dose. Do not exceed a product concentration of 2% V/V maximum. DO NOT APPLY MAX DOSE TO WATER-STRESSED CROPS.

**MIXING INSTRUCTIONS: Citrus&CROPS-H** is compatible with most liquid fertilizers and chemicals. Always perform a jar test for compatibility prior to mixing. Use only according to the label instructions.
