	<p>SOIL-APPLIED: CobaFORCE-H3 can be applied to the root zone through drip irrigation, micro-sprinkler or side-dressing, and can easily be mixed with other chemicals or fertilizers without reacting with other materials. If using CobaFORCE-H3 with liquid fertilizers, use the recommended rate (see right) of CobaFORCE-H3 and add to the liquid fertilizer solution. When used with dry fertilizers, spray 4 to 16 oz / acre of CobaFORCE-H3 to assure reaching root depth.</p> <p>Side Dress: Use 4 to 16 oz / acre</p> <p>FOLIAR-APPLIED: Apply 2 to 8 oz / acre for all crops. When CobaFORCE-H3 is used for foliar applications, whether by aerial or ground application, apply with enough water to thoroughly cover all foliage. Early morning or late evening applications generally give the best results. The use of surfactants / adjuvants is not recommended when using the highest dose.
