MICRODRY Mg is a dry fertilizer with readily available micronutrients that are quickly and efficiently accessed by roots. **MICRODRY Mg** features a EDTA chelation, which makes it ideal for compatibility in tank mixes with most other chemicals and fertilizers.

FOLIAR-APPLIED: Apply **MICRODRY Mg** in sufficient water for thorough coverage. For best results, apply this product in early morning or in late evening. Multiple foliar applications at low rates during the growing season may be the most effective. Use a minimum of 50 gallons of water per acre for low dosage, then progressively increase to 100 gallons of water per acre for maximum dosage.

SOIL-APPLIED: **MICRODRY Mg** should be applied in the root zone through irrigation or side dressing and can be easily mixed with most chemicals and fertilizers without reacting with other materials. **MICRODRY Mg** will perform best when product is allowed to come into direct contact with the plant's roots.

MIXING INSTRUCTIONS: **MICRODRY Mg** is compatible with most liquid fertilizers and chemicals. Mix with a minimum of 5 gallons of water per pound of material and with agitation to ensure proper solubilization. Always perform a jar test for compatibility prior to mixing. Use only according to the label instructions.
