General Information

PK-3250 is recommended to provide Phosphorous to satisfy plant needs, along with Boron, Copper, Iron, Manganese, Molybdenum, and Zinc as plant micronutrients. It is recommended, before any mixing occurs, to conduct a jar test and to check for solution stability.

FOLIAR-APPLIED: Apply **PK-3250** in sufficient water for thorough coverage. For best results, apply this product in early morning or in late evening. Multiple foliar applications at low rates during the growing season may be the most effective. Use a minimum of 50 gallons of water per acre for low dosage, then progressively increase to 100 gallons of water per acre for maximum dosage. Apply 0.25 to 5 lbs/ac for all crops in adequate water. If water volume is below 10 gal/ac use no more than 1 lb/ac.

SOIL-APPLIED: Apply **PK-3250** should be applied in the root zone through irrigation or side dressing and can be easily mixed with most chemicals and fertilizers without reacting with other materials. Apply **PK-3250** will perform best when product is allowed to come into direct contact with the plant's roots.

MIXING INSTRUCTIONS: Apply **PK-3250** is compatible with most liquid fertilizers and chemicals. Mix with a minimum of 5 gallons of water per pound of material and agitation to ensure proper solubilization. Always perform a jar test for compatibility prior to mixing. Use only according to the label instructions.
