SOIL-APPLIED: ZnFORCE-H5 can be applied to the root zone through drip irrigation, micro-sprinkler or side-dressing, and can easily be mixed with other chemicals or fertilizers without reacting with other materials. If using ZnFORCE-H5 with liquid fertilizers, use the recommended rate (see right) of ZnFORCE-H5 and add to the liquid fertilizer solution. When used with dry fertilizers, spray 2 to 10 qt / acre of ZnFORCE-H5 to assure reaching root depth.

Side Dress: Use 1.5 to 8 qt / acre.
