**AGRO-PHITE 0-29\*-26** is a Phosphorous acid-based foliar nutrient solution intended to be used as a supplemental treatment to a regular fertility program and will not supply the total nutrients required by a crop. Upon foliar application, the phosphite ions are taken up directly by the plant foliage and may undergo a degree of conversion to phosphate ions, or will be used directly by plants as phosphite ions. As a soil application to annual crops, a lesser response from the initial crop, with a corresponding superior response from subsequent crops, may be observed. In addition, placement close to seeds or root zones may be injurious to crops. The effect may be aggravated by a soil pH below 6.5.

<b>FOLIAR-APPLIED: AGRO-PHITE</b> for foliar applications, whether by aerial or ground application, should be applied with enough water to thoroughly cover all foliage. Early morning or late evening applications generally give the best results. Do not exceed a product concentration of 2% V/V maximum.
