General Information

MICROLEAF B is a micronutrient specifically designed for foliar application. Very stable in a tank mix, quickly penetrating, and gentle to the leaves.

FOLIAR-APPLIED: When **MICROLEAF B** is used for foliar applications, whether by aerial or ground application, apply with enough water to thoroughly cover all foliage. Early morning or late evening applications generally give the best results. The use of surfactants/adjuvants is not recommended when using the highest dose. Do not exceed a product concentration of 2% V/V maximum. **DO NOT APPLY MAX DOSE TO WATER-STRESSED CROPS.**

SOIL-APPLIED: If using **MICROLEAF B** with liquid fertilizers, use the recommended rate (see below) of **MICROLEAF B** and add to the liquid fertilizer solution. When used with dry fertilizers, spray **0.5 to 2 gal / acre** of **MICROLEAF B** to assure reaching root depth.

Side Dress: Use **0.5 to 2 gal / acre**.

Fertigation: Alone or with fertilizers, apply **0.5 to 2 gal / acre** 2 to 3 times during vegetative growth.

MIXING INSTRUCTIONS: **MICROLEAF B** is compatible with most liquid fertilizers and chemicals. Always perform a jar test for compatibility prior to mixing. Use only according to the label instructions.
