Early morning or late evening applications generally give the best results. The use of surfactants/adjuvants is not recommended when using the highest dose. Do not exceed a product concentration of 2% V/V maximum. <b>DO NOT APPLY MAX DOSE TO WATER-STRESSED CROPS.</b></p> <p><b>SOIL-APPLIED:</b> If using <b>MICROLEAF MIX</b> with liquid fertilizers, use the recommended rate (see below) of <b>MICROLEAF MIX</b> and add to the liquid fertilizer solution.
