**BIO-FORCE Cu OM19** is a micronutrient designed to prevent Copper deficiency in all crops for foliar and soil applications. Very stable in tank mixes, penetrates quickly, and is readily available to the roots.

**AERIAL APPLICATION:** Apply **8 to 16 oz / acre** of **BIO-FORCE Cu OM19** in a minimum of 10 gallons water.

**FOLIAR-APPLIED:** Apply **0.5 to 1.5 qt / acre** in all crops.

**SOIL-APPLIED:** If using **BIO-FORCE Cu OM19** with liquid fertilizers, use the recommended rate of **BIO-FORCE Cu OM19** and add to the liquid fertilizer solution. The product will be the most effective if delivered to the root zone through the irrigation system.

**MIXING INSTRUCTIONS:** **BIO-FORCE Cu OM19** is compatible with most liquid fertilizers and chemicals. Always perform a jar test for compatibility prior to mixing, especially with phosphate-based products. Use only according to the label instructions.
