General Information

BIO-FORCE MIX 7 OM20 is a micronutrient mix designed to prevent deficiency in all crops for foliar and soil applications. Very stable in tank mixes, penetrates quickly, and is readily available to the roots.

AERIAL APPLICATION: Apply **8 to 16 oz / acre** of **BIO-FORCE MIX 7 OM20** in a minimum of 10 gallons water.

FOLIAR-APPLIED: Apply **0.25 to 1 qt / acre** for all crops.

SOIL-APPLIED: If using **BIO-FORCE MIX 7 OM20** with liquid fertilizers, use the recommended rate (see right) of **BIO-FORCE MIX 7 OM20** and add to the liquid fertilizer solution. When used with dry fertilizers, spray **0.5 to 2 gal / acre** of **BIO-FORCE MIX 7 OM20** to assure reaching root depth.

Side Dress: Use **0.5 to 2 gal / acre**.

Fertigation: Alone or with fertilizers, apply **0.5 to 2 gal / acre** 2 to 3 times during vegetative growth.

MIXING INSTRUCTIONS: **BIO-FORCE MIX 7 OM20** is compatible with most liquid fertilizers and chemicals. Always perform a jar test for compatibility prior to mixing, especially with phosphate-based products. Use only according to the label instructions.
