### General Information

**BIO-TRACE MIX** is a micronutrient mix designed to prevent micronutrient deficiency in all crops for foliar and soil application. Very stable in tank mix, penetrates quickly, and is gentle to the leaves and to the roots.

**FOLIAR-APPLIED:** Apply **BIO-TRACE MIX** in sufficient water for thorough coverage. For best results, apply this product in early morning or in late evening. Multiple foliar applications at low rates during the growing season may be the most effective. Use a minimum of 50 gallons of water per acre for low dosage, then progressively increase to 100 gallons of water per acre for maximum dosage.

**SOIL-APPLIED:** Through drip irrigation or side dressing, apply **1 to 8 qt / acre**.

**MIXING INSTRUCTIONS:** **BIO-TRACE MIX** is compatible with most liquid fertilizers and chemicals. Always perform a jar test for compatibility prior to mixing, especially with phosphate-based products. Use only according to the label instructions.
