General Information

PREMIUM 12-26-26 +TE is a water-soluble fertilizer that can be applied foliarly or in the soil. It can be applied to all crops and ornamentals as a supplement to the fertilization plan to prevent and to correct plant nutrition. Best performance may be obtained during plant growth stages. For foliar applications, it is recommended to apply the product early in the morning or late in the evening to avoid high temperatures, which may cause crop injury.

FOLIAR APPLICATION: Apply **PREMIUM 12-26-26 +TE** in sufficient water for thorough coverage. For best results, apply this product in early morning or in late evening. Multiple foliar applications at low rates during the growing season may be the most effective. Use a minimum of 50 gallons of water per acre for low dosage, then progressively increase to 100 gallons of water per acre for maximum dosage.

AERIAL APPLICATION: Apply **5 lbs. / acre**.

SOIL APPLICATION: **PREMIUM 12-26-26 +TE** should be applied in the root zone through irrigation or side dressing and can be easily mixed with most chemicals and fertilizers without reacting with other materials. **PREMIUM 12-26-26 +TE** will perform best when product is allowed to come into direct contact with the plant's roots.

MIXING INSTRUCTIONS: Add water to tank before **PREMIUM 12-26-26 +TE**. Agitate thoroughly while adding remaining water. If used in combination with pesticides, add them last. Alternatively, start from an empty tank and add **PREMIUM 12-26-26 +TE** into the strainer on top and run water through the product, dissolving it while filling the tank. Always perform a compatibility jar test. Do not use additional surfactants without first checking with your agricultural consultant. Do not use when plants are under severe stress conditions, such as water and heat stress. **PREMIUM 12-26-26 +TE** should not be used at a concentration greater than 2 lbs. per gallon of water, unless recommended for a specific situation from your agricultural consultant and after applying to a small area to determine any phytotoxicity effect. Use only according to the label instructions.

CLEANING OF SPRAYER: Flush with clean water all parts of the sprayer, including pump, hoses and nozzles several times prior to and after the use of the product.
