If using <b>SAPFLO-H</b> with liquid fertilizers, use the recommended rate (see right) of <b>SAPFLO-H</b> and add to the liquid fertilizer solution. When used with dry fertilizers, spray <b>2 to 10 qt / acre</b> of <b>SAPFLO-H</b> to assure reaching root depth.  <b>Side Dress:</b> Use <b>2 to 10 qt / acre</b>.</p> <p><b>FOLIAR-APPLIED:</b> Apply <b>1 to 6 pt / acre</b> for all crops. When <b>SAPFLO-H</b> is used for foliar applications, whether by aerial or ground application, apply with enough water to thoroughly cover all foliage. Early morning or late evening applications generally give the best results. The use of surfactants / adjuvants is not recommended when using the highest dose.
