### General Information

**BIO-EARTH** is a soil-applied liquid fertilizer that stimulates crop vitality and confers soil benefits. Applications may begin a few weeks after transplant or during vegetative growth.

**SOIL-APPLIED: BIO-EARTH** is best applied with irrigation water through any available means from drip irrigation or side dressing. It is best if the product is applied toward the end of irrigation to allow it to penetrate and remain in the root zone.

**FOLIAR-APPLIED: BIO-EARTH** is especially designed for soil application but crops can benefit from foliar application, too. Apply **BIO-EARTH** at a rate of **1 to 3 pt / acre** for all crops with enough water for adequate coverage.

**MIXING INSTRUCTIONS: BIO-EARTH** is compatible with most liquid fertilizers and chemicals. Always perform a jar test for compatibility prior to mixing. Use only according to the label instructions.
