General Information

BIO-HEXAL 2-2-8 + TE is an Organic NPK-plus-micronutrient fertilizer solution that can be applied both via foliar means and in the soil, as a supplement to the regular fertilization plan. It can be applied to all crops and ornamentals to prevent and correct plant nutritional deficiencies. Best performance is obtained during plant growth stages.

FOLIAR-APPLIED: Use sufficient water for thorough coverage. Do not apply under poor drying conditions. For fruit trees and vegetables, avoid applying in later stages, when undesired Nitrogen may soften fruit. It is advisable to apply the product early in the morning or late in the evening to avoid high temperatures, which may cause crop injury.

SOIL-APPLIED: Through drip irrigation or side dressing, apply **1 to 20 gal / acre**.

MIXING INSTRUCTIONS: **BIO-HEXAL 2-2-8 + TE** is compatible with most liquid fertilizers and chemicals. Always perform a jar test for compatibility prior to mixing, especially with phosphate-based products. Use only according to the label instructions.
