**HEXA-TEAM 7-22-0 OM6** is a high-quality liquid fertilizer for foliar and soil application in all crops. The high-quality phosphate source ensures all the phosphate provided is in the most available form (orthophosphate). Start applications at planting and during vegetative growth. To improve crop vigor, quality and yield, apply **HEXA-TEAM 7-22-0 OM6** directly through the irrigation system or in tank mixes.

#### FOLIAR-APPLIED:

**HEXA-TEAM 7-22-0 OM6** may be applied at a rate of **1 to 2 qt / acre** diluted in water for adequate coverage. **DO NOT APPLY MAX DOSE ON WATER-STRESSED CROPS.**

#### SOIL-APPLIED:

The best application practice for **HEXA-TEAM 7-22-0 OM6** is to apply through irrigation systems with water to the crop, by available means such as drip irrigation and side dressing. Add product towards end of irrigation to allow for soil penetration and for it to remain in the root zone.

#### MIXING INSTRUCTIONS:

**HEXA-TEAM 7-22-0 OM6** is compatible with most chemicals and fertilizers; however, a jar test should be done before mixing to ensure compatibility. Use only according to the label instructions.
