Multiple foliar applications at low rates during the growing season may be the most effective.</p> <p><b>SOIL-APPLIED:</b> PlantaLIFE is especially designed for foliar applications. However, PlantaLIFE may be applied via soil for benefit at a rate of <b>1 to 2 gal / acre</b> for all crops.
