**FOLIAR-APPLIED:** Apply **TURGOR™** in sufficient water for thorough coverage. For best results, apply this product in early morning or in late evening. Multiple foliar applications at low rates during the growing season may be the most effective. Use a minimum of 50 gallons of water per acre for low dosage, then progressively increase to 100 gallons of water per acre for maximum dosage.

**SOIL-APPLIED:** **TURGOR™** is especially designed for foliar application, but the product may also be applied to the soil for benefits. **TURGOR™** should be applied in the root zone through irrigation or side dressing and can be easily mixed with most chemicals and fertilizers without reacting with other materials. **TURGOR™** will perform best when the product is allowed to come into direct contact with the plant's roots.

**MIXING INSTRUCTIONS:** **TURGOR™** is compatible with most liquid fertilizers and chemicals. Always perform a jar test for compatibility prior to mixing. Use only according to the label instructions.
