### General Information

SET-IT is a foliar-applied liquid fertilizer to be used as a supplement to a regular fertility plan. SET-IT stimulates plant growth and fruit setting as well as aiding in overall plant vigor, fruit size, weight and fruit quality.

**FOLIAR-APPLIED:** When SET-IT is used for foliar applications, whether by aerial or ground application, apply with enough water to thoroughly cover all foliage. Early morning or late evening applications generally give the best results. Apply 2 to 3 times from preflowering to fruit growth. If applying with other products such as PLANTALIFE use a rate of 0.5 pt / acre.

**SOIL-APPLIED:** SET-IT is especially designed for foliar application. However, it may be applied to the soil for benefit at 1 qt / acre to 4 qt / acre on all crops.

**MIXING INSTRUCTIONS:** When mixing SET-IT with other fertilizers, always perform a jar test for compatibility prior to mixing. Use only according to the label instructions.
